The **Subject** of this Agreement is to grant SPIDTECH's Licensed Material(s) to Licensee according to the terms set forth herewith.

By selecting the "I accept" button or by installing, downloading, accessing, or otherwise copying or using all or any portion of the Spider Materials, (i) you accept that you are legally bound by this Agreement or if you accept this Agreement on behalf of another entity for which you are authorized to act (e.g., an employer), you acknowledge that such entity is legally bound by this Agreement, and (ii) you represent and warrant that you have the right, power, and authority to act on behalf of and bind such entity (if any) or yourself. In case you do not have the right or authority to act on behalf of another entity, you shall not accept this Agreement.

If you are unwilling to accept this Agreement, DO NOT SELECT THE "I ACCEPT" BUTTON AND DO NOT INSTALL, DOWNLOAD, ACCESS, OR OTHERWISE COPY OR USE ALL OR ANY PORTION OF THE SPIDTECH MATERIALS.

1.3 SPIDTECH's Responsibilities are (a) granting Licensee a nonexclusive, nontransferable, nonsublicensable, limited license to install and access the Licensed Materials, in each case solely (i) in the Territory, (ii) within the scope of the License Type and the permitted user number, and (iii) in accordance with ALL terms of this Agreement (b) providing SUM services based on the terms of the License purchased.

1.4 Licensee's Responsibilities

1.4.1 Licensee shall be responsible for and pay, if applicable, (a) Licensed Material Price (b) all taxes (excluding income taxes) arising out of granting Software License, including, without limitation, all federal, state, provincial or local property, license, privilege, sales, use, excise or gross receipts taxes or other like taxes and tariffs applicable in any Territory, and (c) all fees and expenses incurred by SPIDTECH in connection with the delivery (if any) of Software and (d) the Price for SUM services (if any).

1.4.2 Licensee is responsible for the compliance of Software with any and all applicable federal, state, provincial and local laws, codes, ordinances, rules, regulations, and administrative orders of the Territory where Software is used, including, without limitation, export and import laws, rules and regulations, engineering and construction laws, and any and all other software safety laws, rules and regulations.

1.4.3 Licensee shall not use, copy, rent, lease, sell, modify, decompile, disassemble, otherwise reverse engineer, or transfer Software except as provided in this Agreement. Any such

unauthorized use shall result in immediate and automatic termination of this Agreement and shall be prosecuted by law.

1.4.4 Under circumstances where a third party, other than Licensee, uses Licensed Material(s), Licensee will be responsible for any results or consequences of work by that third party as a result of using Licensed Material(s).

1.5 Functionality Limitations. Licensed Materials and Services are professional tools, prepared for trained professionals only. Licensed Materials are intended only to help Licensee with design, analysis, estimation, testing and/or other activities and cannot be a substitute for Licensee's own analysis, design, judgment, simulation, estimation, testing, and/or other activities, including those related to product stress, safety and utility. Hence, the ultimate responsibilities of any document prepared by Software shall be totally borne by Licensee. Due to the large variety of potential applications of Licensed Materials and Services, Licensed Materials and Services have not been tested in all situations under which they may be used. SPIDTECH will not be liable in any manner whatsoever for the results obtained as a result of using Licensed Materials or Services. Licensee is responsible for the supervision, management, judgment, and control of Licensed Materials and Services and the results of using Licensed Materials and Services. This responsibility includes, without limitation, the determination of appropriate uses for Licensed Materials and Services and the selection of Licensed Materials, Services and other computer programs and materials to help achieve intended results. LICENSEE ACKNOWLEDGES THAT INSTALLATION OF AND ACCESS TO LICENSED MATERIALS MAY BE DISABLED BY THE SECURITY AND TECHNICAL PROTECTION MECHANISMS IF (a) LICENSEE TRIES TO TRANSFER A PART OR ALL OF THE LICENSED MATERIALS TO ANOTHER COMPUTER, (b) LICENSEE TAMPERS WITH THE TECHNICAL PROTECTION MECHANISMS OR DATE-SETTING MECHANISMS ON A COMPUTER OR IN LICENSED MATERIALS, (c) LICENSEE USES LICENSED MATERIALS PAST AN APPLICABLE SUBSCRIPTION PERIOD OR FIXED TERM, OR (d) LICENSEE UNDERTAKES CERTAIN OTHER ACTIONS THAT AFFECT THE SECURITY MODE OR UNDER OTHER CIRCUMSTANCES AND THAT, IN ANY SUCH EVENT, LICENSEE'S ACCESS TO LICENSEE'S WORK PRODUCT AND OTHER DATA MAY BE AFFECTED.

1.7 Third-Party Licensed Materials. SPIDTECH Materials may contain or be accompanied by third-party software, data or other materials that are provided in accordance with terms that are in addition to or different from the terms specified in this Agreement. In such a case, Licensee agrees to comply with such terms and take sole responsibility for obtaining and complying with any licenses that may be necessary to use third-party software, data or other materials that Licensee uses or obtains for use in conjunction with the Licensed Materials.

SPIDTECH has no responsibility whatsoever for such third-party software, data or other materials.

2. General Provisions

2.1 Territory. Licensee is only permitted to use SPIDTECH Materials both (a) in the Territory that Licensee selects when applying for buying or for trial-version of SPIDTECH Materials on www.spidtech.com and (b) in accordance with the laws, rules and regulations of the Territory where Licensee uses any SPIDTECH Material.

2.2 Use of Name. Except as expressly provided herein, Licensee shall not use the names SPIDTECH or Spider, regardless of the font it is written in, or any of their respective affiliates or divisions or any derivations thereof in any advertisement, publications, or sales materials without the prior written consent of SPIDTECH.

2.3 Language. Only the English language version of this Agreement is legally binding regardless of the Territory where License is purchased or used.

2.4 Force Majeure. “Force majeure”, which includes but is not limited to acts of governments, acts of nature, fire, explosion, typhoon, flood, earthquake, tide, lightning, war, means any event that is beyond one party’s reasonable control and unavoidable with reasonable care of the affected party. However, any shortage of credit, capital or finance shall not be regarded as an event of Force majeure. SPIDTECH will not be liable for any loss, damage or penalty resulting from delays or failures in performance or failure in providing Support service or any other service to Licensee or anyone using SPIDTECH’s Licensed Materials resulting from Force Majeure or other causes beyond SPIDTECH reasonable control.

2.5 Governing Law. All disputes arising out of or in connection with this contract, or in respect of any defined legal relationship associated therewith or derived therefrom, shall be referred to and finally resolved by arbitration under the International Commercial Arbitration Rules of Procedure of the British Columbia International Commercial Arbitration Centre.

2.6 Audits. Licensee agrees that SPIDTECH has the right to require an audit (electronic or otherwise) of the SPIDTECH Materials, their installation, and access. Therefore, SPIDTECH will have the right, on fifteen (15) days’ prior notice to Licensee, to inspect Licensee’s records, systems and facilities, including machine IDs, serial numbers and related information, to verify that the use of any and all SPIDTECH Materials is in conformance with this Agreement. Licensee agrees to cooperate fully with SPIDTECH to enable any such audit. If SPIDTECH determines that Licensee’s use is not in conformity with Agreement, the License granted to Licensee will terminate and any audit costs, including but not limited to all travel costs and investigation incurred by SPIDTECH shall be borne by Licensee.

2.7 Privacy and Use of Information. Licensee acknowledges and agrees that Licensee may provide SPIDTECH with certain information with respect to Licensee (including, without limitation, personal information) and Licensee’s business in connection with this Agreement, including, without limitation, information provided to SPIDTECH through the Customer Information Form and otherwise, in connection with ordering, registration, activation, updating,

validating entitlement to, auditing, monitoring installation of and access to SPIDTECH Licensed Materials, and Services and managing the relationship with Licensee. Licensee hereby consents to SPIDTECH maintaining, using, storing and disclosing such information in conformity with SPIDTECH's policies on privacy and data protection, as such policies may be updated from time to time, including without limitation SPIDTECH's Privacy Policy, as currently located at <https://spidtech.com/privacy-policy.pdf>. Without limitation of the generality of the foregoing, Licensee acknowledges that and agrees that: (a) SPIDTECH may from time to time prompt Licensee to provide express agreement to the terms of SPIDTECH's Privacy Policy and/or express agreement to specific uses of information and data (including, without limitation, personal information); (b) SPIDTECH may provide information and data, including, without limitation, information and data about Licensee's use of SPIDTECH Licensed Materials, and Licensee's support requests, to SPIDTECH or its Resellers and other third parties in connection with the provision, maintenance, administration or usage of Licensed Materials, or Services or in connection with enforcement of any agreements relating to Licensed Materials, or Services; and (c) SPIDTECH may make cross-border transfers of such information and data, including to jurisdictions with privacy or data protection laws that are less protective of Licensee than the jurisdiction in which Licensee is domiciled. Licensee acknowledges and agrees that such policies may be changed from time to time by SPIDTECH and that, effective upon posting on SPIDTECH's website or other written notice from SPIDTECH, Licensee will be subject to such changes.

2.8 Connectivity. Provided that under certain conditions, some Licensed Materials require or permit Licensee's access to and use of content and services of a third-party website on the Internet, such connectivity to websites of third parties is governed by the terms (including the disclaimers and notices) found on such sites or otherwise associated with the third-party content or services. SPIDTECH does not control, endorse, or accept responsibility for any such third-party content or services, and any dealings between Licensee and any third party in connection with such content or services, including, without limitation, such third party's privacy policies, use of personal information, delivery of and payment for goods and services, and any other terms associated with such dealings, are solely between Licensee and such third party.

2.9 Serial Number Required. Installation of and access to Licensed Materials, either under trial or under any other license, or any other license type, require, and the continued use thereof may require, Serial Numbers issued by SPIDTECH. Licensee will provide SPIDTECH with any information needed for such registration and agrees that any information provided to SPIDTECH will be accurate and current.

2.10 SUM Services. Licensee might be entitled to a period of SUM Services of Software as of the date of invoice issue and based on the License purchased. Details of SUM Services' price and entitlement are included on the Quote.

2.11 Termination. The license granted is effective until terminated. Negligence to observe any term of this Agreement entitles SPIDTECH to terminate this Agreement and stop Licensee from using the Materials that Licensee has obtained. Licensee shall not continue using SPIDTECH Material(s) if SPIDTECH determines that Licensee has failed to follow any of the terms in this Agreement. Licensee may also terminate it by destroying Software, the

documentation and copies thereof. Licensee agrees upon such termination to destroy all copies of the program and of the documentation, or return them to SPIDTECH.

2.12 Severability. If any provision of this agreement is held invalid, illegal, or unenforceable under applicable law, such provision will be deemed modified to conform to applicable law. Such probable invalidity, illegality, or unenforceability of such provision will be ineffective as to the jurisdiction in which it is invalid, illegal, or unenforceable. The illegality, invalidity, or unenforceability of such provision in that jurisdiction will not in any way affect the legality, validity, or enforceability of such provision or any other provision of this Agreement in any other jurisdiction.

2.13 Survival. Sections 1.1 (Liability Disclaimer), 1.2 (SPIDTECH Limited Liability), 1.4.2, 1.4.3, 1.4.4, 1.5 (Functionality Limitations), 1.6 (Disabling Access), 1.7 (Third-Party Licensed Materials), 2.2 (Use of Name), 2.8 (Connectivity), and All Rights Reserved, as well as Exhibit A will survive any termination or expiration of this Agreement.

2.14 Deal Finalization. The deal is final once Licensee accepts the terms of the Agreement and the Quote and pays the fees thereof. Afterwards, the deal will go through, and there is no way whatsoever to stop the deal.

Exhibit A Definitions

1. **Agreement** means this contract and the information presented herewith, either in paper or electronic, for Licensee to read carefully and agree with.
2. **License** is the document providing legally binding guidelines for the use, as stipulated herewith, of Software. License provides Licensee with the right to one copy of Software following the terms of this Agreement and without violating copyrights.
3. **Licensed Materials** means Software, SUM Services, and Supplemental Materials (if any) (a) downloaded by clicking on the “I accept” button or another button or mechanism associated with this Agreement or by otherwise consenting to this Agreement, (b) delivered packages (if any) with this Agreement, or (c) otherwise accompanied by this Agreement. In any case, Licensee has paid (and continues to pay) the applicable fees of Licensed Materials.
4. **Licensee** is (a) the legal entity including, but not limited to, a person or a company that agrees with the terms of this Agreement and acquires SPIDTECH Materials (b) the company or other legal entity on behalf of which SPIDTECH Materials are acquired.
5. **Lifetime License** is a License valid for as long as Licensee can use Licensed Materials purchased.
6. **Maintenance** means the modification of Software after online delivery to correct faults, if any.
7. **Multi-User License** is a license type, which can be installed to, and operated, viewed or otherwise accessed by Licensee from multiple computers based on the number of seats specified on the Quote.
8. **One-Year License** is a License valid for one year after activation.
9. **Price** means the invoiced amount that Licensee pays for Licensed Materials through internationally accepted credit cards such as valid Visa Card, Mastercard, American Express, Discover, PayPal account, or through another mechanism accepted by SPIDTECH in written.
10. **Quote** is a document listing the prices and terms proposed by SPIDTECH Corporation for its Licensed Materials and offered to the Licensee.
11. **Reseller** means a distributor or reseller authorized directly by SPIDTECH to distribute authentic Licensed Materials to Licensees.
12. **Seat** is a Licensee granted access to Licensed Materials, specifying how many users can install, or operate, view or otherwise have access to Licensed Materials.
13. **Serial Number** means the serial number for Licenses issued by SPIDTECH for Licensed Materials to be installed and used.
14. **Services** means services (including the results of services) provided or made available by SPIDTECH, including, without limitation, Support services.

15. **Single-User (Individual) License** means the Licensed Materials may be installed on different computers but Licensee can only be logged in on as many as two computers. Licensee, nonetheless, cannot simultaneously use Licensed Materials on two computers. Licensed Materials may be accessed on just one computer at any given time.

16. **Software** refers to Spider as well as corresponding documentation, associated media, and online or electronic documentation, whose functionalities are defined by SPIDTECH. The term Software may also refer to functions and features of Spider. Software is supplied through www.spidtech.com or its approved resellers.

17. **SPIDTECH** is SPIDTECH Structural Software Inc. registered at Corporations Canada as a Federal Corporation. The Corporation Number is 717821-2.

18. **SUM Services** include Support, Upgrade, and Maintenance.

19. **Supplemental Materials** means materials, other than Software, that are made available by SPIDTECH for use with Software. Supplemental Materials include, without limitation, (a) content, such as sample detailings and designs, modules for detailing and design, and representations of elements used in detailings and designs (e.g., buildings or parts of buildings), (b) background materials, such as building codes and descriptions of building practices, (c) tools for rendering the output of Software, such as fonts, and (d) Development Materials, application programming interfaces (APIs), and other similar developer materials (including API Information).

20. **Support** means resolving, if possible, Licensee's sales and technical questions related to Software, by ticketing, chat, email, or phone.

21. **Territory** means (a) the country, countries or jurisdiction(s) specified in SPIDTECH registration form (Customer Information Form) when attempting to create a profile on SPIDTECH website or its resellers' websites.

22. **Three-Month License** is a License valid for three months after activation.

23. **Trial License** is a free version of Software to be used on one computer only and for a period set on the Quote.

24. **Upgrade** means replacing Software with a newer version, which may incorporate error corrections or may enhance or add to the features or functionality of the prior release.

25. **User** is an entity who can install, or operate, view or otherwise have access to Licensed Materials on a computer.

Exhibit B License Types

License Types Based on the Number of Users

1. Single-User (Individual) License:

Licensee may install only one single primary copy of the Licensed Materials purchased or downloaded on one computer, a Single-User License, and solely for Licensee's internal business needs. Licensee shall not let others use Licensee's Licensed Materials.

2. Multi-User License:

Licensee may Install copies of the Licensed Materials purchased or downloaded, and use such Licensed Materials on multiple computers based on the terms designated on the Quote. Such License shall solely be used by Licensee's personnel and for Licensee's internal business needs. Licensee shall not share Licensee's Licensed Materials with other companies, corporations or businesses whatsoever.

License Types Based on Validity Period

- 1. Three-Month License:** This License is valid for three months after activation. The continued use of the License needs recurring payment, set on the Quote.
- 2. One-Year License:** This License is valid for one year after activation. The continued use of the License needs recurring payment, set on the Quote.
- 3. Lifetime License:** This License is valid for as long as Licensee can use Licensed Materials purchased.
